

3 Carbon Reduction Projects



The following environmental management measures and projects have been previously implemented because FlyForm has always been a climate conscious organisation. As this report sets our baseline the reductions achieved by these schemes are unable to quantified.

3.1 Completed Carbon Reduction Initiatives

- IT Equipment Replacement FlyForm doesn't replace devices on a schedule and regularly monitors device performance and device requirements to only replace devices when required.
- Remote Working All FlyForm's employees are able to work remotely and encouraged to do so when possible.
- Recycling and Waste Waste is minimised and recycled at all office locations for improved disposal and reduced environmental impact.
- Paperless FlyForm is already largely paperless, and recycling bins are provided so wastepaper can be recycled where possible.
- Public Transport Our existing travel and expenses policy encourages the user of public transport where possible, as a way to reduce our carbon footprint.
- Office Lighting All lighting is LED and controlled by motion sensors to reduce energy consumption.

3.2 Planned Carbon Reduction Initiatives

In the future we hope to implement further measures such as:

- IT Equipment Repairability When purchasing devices, the ability to easily repairability and the available of parts is consider, so that the life of devices can be extend instead of device being replaced prematurely.
- Electric fleet The existing 6 vehicle fleet included primarily hybrid vehicles, these will be transitions to fully electric by 2030.
- Cycle to work scheme FlyForm already encourages the use of bicycles as a method of commuting
- Business travel, visibility and policy Implement request process and improved data collection for business travel.
- Tracking additional information Improve tracking and monitoring of data to enhance the quality of our emissions reporting.
- Improved travel policy Formalise sustainable travel policies to actively encourage and support users to use more public transport when travel is necessary.
- Employee support Investigate offering schemes for employees to support more sustainable travel including cycle to work and salary sacrifice for fully electric vehicles.
- Paperless Improved paperless operations to further reduce paper usage across the business
- Supply Chain Engage with suppliers to better understand the upstream emissions sources from our suppliers.
